Key West Storm Veers Out to Sea

Goes Out Florida Coast at Miami After Causing Immense Destruction of Property Along the Atlantic.

Damage in Key West Estimated at \$2,000,000; Plunderers at Work; Heavy Loss of Life Feared.

(By Associated Press Leased Wire.) WASHINGTON, D. C., Oct. 12.—All danger to points in the Gulf of Mexico and the Atlantic Coast from the West Indian hurricane which reached Key West and swept northwest over Florida has passed according to the weather bureau today.

The tropical storm, after passing over Key West crossed the Florida peninsula and went out to sea at Miami. The disturbance is now continuing with unabated force northwesterly along the Gulf stream and is heading toward the Bermudas.

The exact location of the center of the tropical disturbance this morning, as indicated by the reports to the weather bureau, is between 200 and 300 miles off Jacksonville, Fla. The usual path of the west Indian hurricanes which come up from the Gulf and sweep the Atlantic coast is to pass to sea anywhere between Key West and Norfolk, then to veer north easterly and continue into the north Atlantic. Storms of previous years have been known to continue their destructive paths all the way across the Atlantic leaving in their wake many a wrecked vessel.

Spends Its Force. At Key West this morning the storm had spent its force. A stiff northwest wind was blowing and a heavy rain was falling. The thermometer registered 82 at 8 o'clock. Reports from Tampa, Fla., indicated that the storm was little felt there, the disturbance having passed somewhat to the south of that place. There being no observer of the weather bureau at Miami, no reports of the effect of the hurricane in that city have been received here. All storm warnings on the Atlantic and Gulf Coasts have been ordered discontinued but the weather bureau advises shipping interests that the hurricane is continuing over the Atlantic and caution should be exercised by (Continued on page eight.)

Nothing But a Duke for Marjorie

The Grand Duke Alexander Georgievich Romanovskii received much attention from Miss Gould in London. He is 28, a cousin of the czar, rich, handsome and military. He is entitled to be called "Your Imperial Highness."

There's also the duke of Alba, who says much of Miss Gould while she is abroad. He has a string of Spanish, English and French titles, and he's all mixed up with royalty. Then there's Prince Francis Joseph, brother of Prince Miguel who recently married Miss Anita Stewart. He isn't as rich as the other two, but he's named for Emperor Francis Joseph of Austria, and the emperor favors his wailing of Miss Gould.

Brother of Assassin Feels Shame; President Stays With Sister and Starts on Rounds Again.

(By Associated Press Leased Wire.) LOS ANGELES, Oct. 12.—"Lock me up. I don't want to be shadowed all day," said a clean-looking well-dressed laboring man, who walked into Los Angeles police headquarters alone yesterday.

"What do you want to be locked up for?" asked the police captain. He hesitated, glanced about to see that he was not overheard and said quietly: "My name is Czolgosz."

And so it happened that the brother of the man who died for having robbed the nation of the life of one of its presidents voluntarily sat in a police station while President Taft was driven through the streets. Aside from his relationship to one whose name is mentioned only in shame, the man has nothing about his life which he needs hide.

President Taft today at 9 o'clock began the second day as the guest of Los Angeles and adjoining cities of Southern California. After a night's rest at the home of his sister, Mrs. W. A. Edwards, following the banquet in his honor last night the president arose early and was met by a local committee and taken by trolley car to the National Soldiers' Home at Sawtelle, ten miles from Los Angeles.

Thousands of the old veterans congregated at the station or lined the walks through the grounds and cheered the chief executive. The president grasped the outstretched hands of many of the veterans. When the car reached Los Angeles on the regular journey it was met by automobiles into which the party was loaded and the trip through Los Angeles began.

At a luncheon President Taft spoke briefly, his remarks dealing principally with the topics which he has previously dwelt on.

OFFICIALLY DEPARTS MR. CRANE

Secretary Knox Notifies New Minister to China That His Resignation Will Be Very Acceptable.

Explanatory Statement Given Out at State Department, Tells of His Non-Diplomatic Actions.

(By Associated Press Leased Wire.) WASHINGTON, Oct. 12.—Secretary of State Knox early this afternoon informed Charles R. Crane, minister designate to China, that he would accept his resignation. Mr. Crane had already advised the secretary that he was prepared to resign if the recent developments had made his further service in that position embarrassing.

Mr. Crane had advised President Taft of his action. Should Mr. Crane accede to the secretary's suggestion, which it is taken for granted he will do promptly, his resignation will be addressed, not to the state department but to the president who appointed him. Mr. Crane, when seen at his hotel this afternoon, said he had received a formal letter from Secretary Knox requesting him to tender his resignation as minister to China. Mr. Crane had not seen the statement given out at the state department and declined to talk for publication until he could read this.

China-Japan Agreement.

In announcing his action, Mr. Crane gave out a statement in which he said: "The department of state has been engaged for some time in making the usual study of the recent agreements between China and Japan in relation to Manchuria, with a view of determining whether there is anything in the agreement adversely affecting American interests or in conflict with the principle of equal opportunity to which the powers are pledged; a study not yet concluded and in respect to which no decision has been reached. While this investigation was proceeding, Mr. Crane, minister to China, came to the department and while there was informed by one of the clerks that such an examination was being made."

"Without the knowledge or authority of any one connected with the department, Mr. Crane gave out a newspaper story to the effect that this government was preparing to protest against some features of the agreements and that the promulgation of the protest only awaiting the return of an official who was to formulate it."

Published in Japan.

"The story appeared in a western paper and at the same time or a day later in the Japanese press and subsequently was generally published. At a conference with Mr. Crane Sunday evening he admitted having an indiscreet talk with a reporter which resulted in the publications referred to and assuming responsibility, stated that if he had been more discreet enough to shake my confidence in his usefulness he would willingly resign. I have reluctantly reached the conclusion that the good of the service demands that I should tender a resignation which will be accepted and I have done so."

MEET TO DISCUSS ELECTRIC ARCHES

Special Session of Those Interested Is Called for Wednesday Evening at the Commercial Club Rooms.

President Gray and Secretary Clement of the Commercial club have issued a call for a meeting to be held Wednesday evening of this week of those interested in maintaining the brilliant electric arches as a permanent feature of downtown Kalamazoo.

The plan is to have a practical demonstration of what such lighting means to a city. Other cities, in Michigan and elsewhere, have adopted the arch system, the down town merchants in many instances paying for the current pro rata.

Everyone seems agreed that the arches should be maintained. The means to accomplish this will be discussed Wednesday night, when it is hoped there will be a large attendance.

LET'S THE CONTRACT FOR DREADNOUGHT

United States Now Has Great Lot of Battleships Under Way.

(By Associated Press Leased Wire.) WASHINGTON, D. C., Oct. 12.—Secretary Meyer has signed the contract with the New York ship building company for the construction of the dreadnought battleship Arkansas. As heretofore announced the William Cramp and Sons Company are to build the other dreadnought Wyoming, authorized by the last congress.

With these two great war vessels on the ways the navy department will have under construction seven battleships in all, the Arkansas, Wyoming, South Carolina, Delaware, North Dakota, Florida and Utah.

The South Carolina, Delaware and North Dakota are 35 or more per cent completed. In addition there are under way the Delaware, two torpedo boat destroyers and sixteen submarines.

Dr. Geisel, in Talk Last Night, Told How Famous Diva Gave Her a Garment as Proof.

Mme. Adeline Patti never squeezed out a top-note by the aid of a corset. Dr. Carolyn Geisel, of Battle Creek, says so and flourishes Exhibit A in proof of her assertion.

Exhibit A is a dainty, lace-trimmed combination corset cover and trousers, made impressive from the fact that they had been worn by Madame Patti, and which Dr. Geisel displayed last night in the course of her address before the members of Miss Parsons' Sunday school class and their guests in the First Presbyterian church.

In speaking of the Patti garment Dr. Geisel said: "This garment was given to me by Madame Patti herself during my recent visit to her. She was attired in a handsome gown which fitted perfectly and I said: 'Do you think I would wear a corset? Do you think that I would deprive the world of hearing the voice which God has given me by wearing a corset?' Madame Patti then removed this undergarment and gave it to me that I might be assured that she was wearing only healthful hygienic garments."

"This is the sort of underclothing that Patti wears," said the speaker, displaying the garment. "And is the reason that she is able to charm thousands of people in her audiences. It is the kind of undergarment that every thinking woman should wear." Dr. Geisel illustrated her lecture with the same skeleton and little blue corset which were used during her recent address before the W. C. T. U. and denounced the corset in the same strong language.

BLINDING STORM CAUSES A CRASH

Furniture Van Driver Turns in Front of Street Car With Disastrous Result; Two Rigs Smashed.

Blinded by the heavy snow fall, and unconscious that a south bound M. U. car was approaching, A. J. Boggs, driving a heavy furniture van, turned his horses across the street car tracks in front of Fitzgerald Bros. store, 538 Portage street, this morning, and the next moment car and wagon collided.

The furniture van was pushed along the track for several feet, and then to one side, where it toppled over on a light delivery wagon owned by Fitzgerald Brothers. The light vehicle was reduced to splinters and the horse to which it was attached was cut on both legs.

Motorman Wicks, an extra man on the M. U. R., is said to have rung the gong repeatedly, and tried to slow down the car when he saw that a crash was unavoidable.

The furniture wagon was badly damaged, but Mr. Boggs, who was driving, escaped without injury. Little damage was done to the car.

When Mrs. Minnie Stewart was attacked with a sudden indisposition Monday evening she bethought herself a favorite remedy in the form of pills which were in a box on her dresser.

Lighting the gas, Mrs. Stewart hunted among hat-pins, ribbons, laces and toilet bottles until she brought to light the medicine.

Pushing open the sliding cover of the box, Mrs. Stewart took out a pill, but found that there was attached to it what seemed to be a heavy piece of gold bullion thread.

Attempting to pick off the thread Mrs. Stewart turned closer to the light, she was astonished to find that instead of a pill she held a diamond ring, and the thread was the gold band on which it was mounted.

The stone weighed about a karat, and as it flashed its radiance into her eyes the woman forgot her illness in her surprise at her lucky find.

How the ring got into the pill box is a mystery. The box of medicine had been on the dresser for weeks, but had not recently been opened.

A solution of the "mystery" Mrs. Stewart thinks may be found in the fact that some months ago she rented a number of furnished rooms to a family, and after their departure from the city a number of pieces of silverware and other articles were missed.

With the aid of an officer the stolen goods were recovered. "Perhaps," said Mrs. Stewart, "this ring had been stolen somewhere and hidden in the pill box but forgotten when the family left my house."

COMPLETES HIS INSPECTION.

Air was far too cold for good baseball. A brisk and chilling breeze prevailed and on the whole it would be hard to imagine a worse day for good baseball.

The eagerness of the national commission to win the game of both teams to avoid any delay in bringing the crucial series to a finish will cause them to make every effort to play today.

The brilliant finish in the closing of yesterday's battle inspired fresh hope in the breasts of the local supporters despite the defeat of their team.

The Detroit players were determined to win the next game played because they do not they will be practically out of the running. If Pittsburg leads by three games to one, Detroit's chances will not amount to much. Manager Jennings figured that if his team could win this game and tie the series with two victories each, Detroit would have an excellent chance of winning the championship.

The thermometer registered slightly above the freezing point during the morning but the national commission said that nothing short of a blizzard would stop the game.

There are indications that the snow storm prevailing in the western part of the state might arrive here before the game could be finished.

The national commission met this morning and took action on the much discussed Murphy-Pfeiffer case but will withhold its decision until tomorrow when it will be announced at Pittsburgh. None of the members of the commission would intimate what the decision had been, but it is thought President Charles W. Murphy, of the Chicago Nationals will be given a certain time in which to file his appeal. He was fined for the alleged tampering with Pitcher Pfeiffer of the Toronto Eastern League Club.

The United States weather bureau at 1 p. m. gave the temperature as 35 degrees above zero. A few flakes of snow fell during the morning.

The players came on the field in heavy sweaters and refused to discard them during the practice although most of them had sweaters concealed beneath their uniform shirts. Despite the cold the practice of both teams was snappy and many good plays brought rounds of chilled applause from stands.

BANK BUILDING TO BE ENLARGED

Plans Discussed at Meeting of Kalamazoo Savings Directors This Afternoon, When Consolidation Is Approved.

Plans already announced for the consolidation of the Kalamazoo Savings bank and the City National bank, under the name of the former, were approved at a meeting of the Directors of the Savings bank this afternoon, and steps were taken for their immediate execution.

Vice President R. J. Williamson, the former Kalamazoo banker, was present at this meeting, his first appearance since his unfortunate accident last winter.

Architect's plans for the addition to be erected just east of the present Savings bank building were taken up and discussed. The addition will entirely fill the vacant space between the bank building and the Edwards & Chamberlain block and will be of the same general character as the present building, the two to be joined in one harmonious whole. The new part will be occupied by the savings department while the commercial bank, now in the consolidated bank will occupy the quarters covered by the present building. It is believed that the new structure will be enclosed before winter sets in.

It was stated today that the consolidation of the banks takes in the entire official force of both institutions, officers, directorate and employees.

PLACED FLOWERS ON WRONG GRAVE

Police Note Invites Woman to Desist From Practice.

NEW YORK, Oct. 12.—"Please do not put any more flowers on my grave," was the message on a piece of cardboard which Mrs. McDonald, Brooklyn, found on the grave in Mount Cemetery on which for fifteen years she had been placing flowers weekly.

Believing that it was the grave of a dead relative, Mrs. McDonald was indignant and protested to the superintendent of the cemetery. He looked up the records and found that the relative was really buried some distance from the grave which she had been so faithfully decorating.

First Three Games Bring Play-

DETROIT, Mich., Oct. 12.—Pande-
monium reigned in this city last night
as a result of the great victory gained
by the Pirates over Jennings' lords of
the Jungles. Pittsburgers to the number
of over 5,000 were in town to see the
game, also the one scheduled for today,
and they did their best to let everyone
know how much they gloried in their
victory. They packed hotels, cafes and
theaters and cheered and sang and let
loose all sorts of gladsome sounds.
They paraded the streets long after
midnight and kept up the din and up-
roar. Everything was eminently good
natured, quite typical of the American
love for fair play. Detroiters had
celebrated in Pittsburg after the great
victory of Saturday and no one seemed
to begrudge the visitors a good time
here.

The receipts from yesterday's crowd
reached \$20,676, making the total for
the three games \$102,832. This is but
\$4,000 less than the greatest amount
ever taken in for an entire world series.
The national commission deducts
10 per cent, or \$2,067.68. The players'
share is \$11,455.04, and the amount for
each club \$3,721.68.

With the conclusion of today's game
the players cease to share in the pro-
ceeds. Basing the estimate on pre-
vious receipts some idea of the amount
each contestant in the series will re-
ceive may be gleaned. Something over
\$55,000 should be the amount to be di-
vided, 60 per cent to the winners and
40 per cent to the losers, in the series.
In this event the world's championship
club will have \$33,600 to divide, while
\$28,400 will be the losers' share.

There are about 12 men on the De-
troit team and as many on the Pitts-
burg outfit, who will be eligible for
some of the prize money. This means
that each member of the winning ag-
gregation should pocket about \$1,800.
Players on the losing team will have
to content themselves with about \$1-
200 each.

The Detroit club announces that
should a sixth game be played, it will
be at Bennett park, first come first ser-
viced. Should Pittsburg win today it
will not be known until Wednesday night
whether or not a sixth game is neces-
sary. This will allow no time for other
arrangements; hence the above plan.
Should Detroit win today, a sixth game
will be necessary, and tickets will be
placed on sale at the park Wednes-
day morning.

DR. GLADDEN'S BOOK.

There are men with boyhoods like Lincoln's in the world today. One of them died the other day, governor of a great state.

Another, in Columbus, O., has just written a modest autobiography. He is Dr. Washington Gladden, noted Congregational moderator and author of the phrase "tainted money."

In his book, which he calls "Recollections," Dr. Gladden has preached a sermon to all boys for all time. It is "don't be discouraged." It is an old sermon, as old as the history of Washington, or Lincoln; as recent as the lives of Gov. Johnson, of Explorer Cook.

Dr. Gladden's rise from a chore boy in rocky fields to a place of national prominence is simply told. Any boy who needs the sermon he preaches can understand it.

"My mother," he says, "thought it best to place me in the care of my uncle, Ebenezer Daniels, on the farm where I had lived after my father's death. After the chores were done and the supper was cleared away, there were often two hours of reading before our early bedtime.

"My uncle was the reader in the earlier years, and he always read aloud, sometimes by the light of pine knots.

"As I grew older my uncle occasionally drafted me into service as a reader for a part of the evening, and in that practice I learned the most of what I have known of the art of oral expression.

"The life into which I was introduced was by no means a life of ease or luxury. It was only by the most tireless and constant labor, early and late, that we were able to win from the intractable soil a means of livelihood."

Under the head of "A Political Retrospect" a closing chapter, he says: "Anything more immoral than the general attitude of the national legislature as displayed in the tariff debate of 1909 it would be difficult to imagine."

An unwritten page in the history of Roosevelt's settlement of the great coal strike of 1902 is told by Dr. Gladden as follows:

"The editor of the Cincinnati Post, a daily newspaper circulating largely among the working classes, came to Columbus to consult with me about this. (The settlement of the strike.) He wished to circularize, widely, a petition to the president asking him to intervene, and he desired me to frame the petition.

"* * * I asked the editor to let me think about it an hour, and at the end of that time I found myself convinced that Mr. Roosevelt would neither refuse the task nor fail in it; and that a strong demand laid on him by the people might enable him to do what he would not feel like doing on his own initiative. I therefore wrote him."

The result is a part of the country's history. Roosevelt intervened, and the strike was ended.

HE SLEPT ON THE ROOF.

Do you remember how a few years ago the newspapers were filled with glee over the stories that the late Sam Jones, then mayor of Toledo, O., slept out on the roof of his back porch?

Pictures were printed of the back porch, and X marked the spot where the bed stood.

After the reporters and the correspondents had told the story, the editorial writers and the jokesmiths and the comic artists and the cartoonists had fun with it.

And you used to hear people say that a man was "as crazy as Sam Jones."

The thing was stock campaign argument when the street car companies and the light company and the usual combination of "best citizens" used to try to best the old man for re-election.

And now an architectural journal tells us that "the greatest change in residence architecture is the addition of sleeping porches."

It goes on to say that this demand is equally strong, east, west, north and south.

Wherever good men, honest men, go when they die, Sam Jones has gone.

And we who laughed at his "crazy notions" are trailing along years behind him, just waking up to the fact that God made the fresh air for us to breathe, and that sleeping in close, stuffy rooms will invite colds and sickness and hurry us to the long sleep in the cold little room down in the ground.

From MARY'S COOK BOOK



A housekeeper after my own heart is this one who asks for a recipe for meat pie, or it's a favorite dish with housewives whose ways are old-fashioned and whose kitchen sense is sound. As there's an "r" in September it will be permissible for you to use oysters—so I'll give you a recipe for a giglet pie with oysters: Take giglets of two chickens or a turkey, stew until nearly done and cut into inch pieces; line the pie with rich paste; mix the giglets with a quart of oysters, adding enough liquid to make the pie juicy; add flour or rolled crackers enough to thicken it slightly; also butter, pepper and salt; cover with a crust and bake until the top is browned.

Still another substantial pie is made of veal. This is the recipe: Cut three pounds of lean veal into inch squares, put in a saucepan with a cupful of cold water and heat slowly; remove the scum as it begins to boil; add two small onions, sliced, two tablespoonsful of carrot cubes and one teaspoonful of salt; let it simmer until tender; put the meat in a deep baking dish; let the liquid boil down one-half; strain it and remove most of the fat; add one-half a cupful of cream or of rich milk, and pepper to taste; thicken it with a tablespoonful of flour rubbed in one of butter; cook it five minutes and strain it over the meat. If you have any cold boiled ham, you may add a little of it to the veal, cut it in tiny bits; cover with rich biscuit dough half an inch thick and bake one hour; cover with thick paper; uncover and brown for 10 minutes before sending to the table.

While Woods and Wilson were talking, Bullock drew two revolvers and ordered them to throw up their hands. Then he marched them into a vault and locked the door. He took \$1,000 and fled.

Two hours later citizens released the men from the vault and a search for Bullock was started. Policeman Pringle traced the boy to his mother's home, and went there to capture him. Bullock shot down the policeman and made a successful dash for liberty.

THREE CHINAMEN DIE IN CATHOLIC FAITH

Were Electrocuted for Murder of Four Countrymen.

[By Associated Press Lensed Wire.] BOSTON, Oct. 12.—Three Chinamen, Min Sing, Leong Gong and Hom Woon, were electrocuted at the state prison in Charlestown for the murder of four of their countrymen in a "long war" in Chinatown.

The crime for which they were convicted was the "shooting up" of Boston's Chinatown on August 2, 1907, when four Mongolians met their death, and a dozen were injured.

Hom Woon was the first to be led to the electric chair. The second was Min Sing, and the third, Leong Gong. A day or two ago the condemned men were received into the Roman Catholic faith, and Rev. Father Austin D. Malley accompanied each of them to the electric chair.

PLAN WELCOME TO GOMPERS

Union Labor Leaders in Washington Arrange for Great Reception in Form of a Big Parade.

[By Associated Press Lensed Wire.] WASHINGTON, Oct. 12.—American labor will honor in the capital tonight the man who is perhaps the most powerful leader in the organized working world today, the returning president of the American Federation of Labor, Samuel Gompers.

Preparations have been made by the union laborers of the city to give their chief a welcome which he will not forget for a long time. The welcome will be in the form of a great parade in which it is expected more than 25,000 men from Washington and other cities will appear, and which will be reviewed by Mr. Gompers to be followed by a mass meeting in convention hall where formal addresses of welcome will be made by district commissioner West, Franklin K. Lane of the Interstate Commerce commission, John Mitchell, former president of the miners' union, and others.

Mr. Gompers in a speech at Convention hall will tell of the lessons he has learned and the comparisons he has drawn by his recent study of labor conditions in Europe where he was sent by the organization of which he is the head.

HEALTH OFFICER CALLED BY COMMON COUNCIL

Officer Declared to Have Been Careless in Performance of Duty.

[Special to the Evening Telegraph.] BAY CITY, Mich., October 12.—The council has demanded an explanation from Health Officer Freiberg as to alleged neglect in permitting Charles Freiberg, a milkman, to deliver milk after Freiberg's children were ill with the disease. About 80 cases, the earliest of the epidemic, were among Freiberg's customers. The health officer, it was declared, is Freiberg's family physician.

Alderman Fletcher, who introduced the resolution, declared that his brother-in-law, County Auditor D. D. Mount, held his baby in his arms as it died last Saturday from scarlet fever, and that Mount was permitted to come and go whenever he pleased. He also alleges that a saloonkeeper whose three children were ill with the disease was permitted to live at home and to continue serving his customers without restrictions.

Four deaths have occurred within 10 days. There are now about 75 cases, but the health officer alleges the worst of the epidemic is over.

A storm with the features of a blizzard, which, like the January robin, has arrived ahead of the season, began shortly after midnight, and continued, with whirling flurries of snow, throughout the early hours of the day, with the prospect that there will be no abatement, before night.

This storm, coincident with but separate from the Florida coast hurricane, according to reports covers a wide area of territory. Kalamazoo is experiencing it with all Michigan, reports of the storm coming from every city in the state, Wheeling, West Virginia, Dayton, Ohio, Des Moines, Iowa, Winona, Minnesota, New Richmond, Wisconsin, Duluth and other widely separated points reported snow and gales during the night, indicate the extent of the present disturbance.

The snow of today followed a cold rain of Monday. Early this morning it turned to snow filling the streets with slush and water. In some places the streets were almost impassable. People walked with bent heads and umbrellas collisions were frequent. Business was delayed and travel for horses was accomplished with difficulty.

Traffic Interrupted.

Street car traffic was somewhat delayed. The snow was accompanied by a raw cold wind which shifted from east to south and drove the hard particles of snow straight into the face. Trees were weighted down by the heavy snow and in some places they were bent to the ground. In Brownson Park the tops were broken off from two large maples and on other streets broken trees were seen. Throughout the day the streets were deserted, only a few stray pedestrians, whose business demanded it, being seen about the streets. Business was at a standstill.

Telephone and telephone service was greatly crippled and much difficulty was experienced on the local telephone lines. In some places wires were down and in other cases there were crossed lines.

Makes Business Bad.

"Street car traffic has not been seriously handicapped by the storm," said Superintendent Smith, "but, of course, the boys are put to some inconvenience by the way the snow sticks to the windows, and makes the outlook almost impossible. However, we have had but one accident today, and do not expect any more. The men have been cautioned to run the cars safely, and are taking no chances."

Associated Press reports give a clear idea of the progress of the storm in Michigan. Lower Michigan received its first installment of real winter today. With the temperature hovering between twenty and thirty degrees, snow fell intermittently over almost all of the lower part of the state. A thirty mile and hour wind prevailed and made the snow flurry resemble a winter blizzard in many places.

Causes a Wreck.

The first snow storm of the season was responsible for a collision this morning that resulted in a street car going to the shops for repairs and a motor truck being badly wrecked.

SUES FOR INSURANCE OF MAN LEGALLY HANGED

United States Supreme Court Asked to Give Decision.

[By Associated Press Licensed Wire.] WASHINGTON, D. C., Oct. 12.—The question of whether the ordinary insurance policy insures a man against death by legal hanging is raised in the case of the Northwestern Mutual Life Insurance company vs. J. William McCue and others which was

presented today to the Supreme court of the United States.

McCue is one of the children of the late Mayor J. Samuel McCue, of Charlottesville, Va., who was hanged for murdering his wife.

About a year previous to the crime, McCue took out a policy of \$15,000 in the Northwestern Mutual Life and the company refused to pay the policy on the ground that "the death of the insured because of hanging under sentence of a court of justice, annulled the contract of insurance."

The United States circuit court for the western district of Virginia gave a verdict in favor of the company, but that verdict was reversed by the United

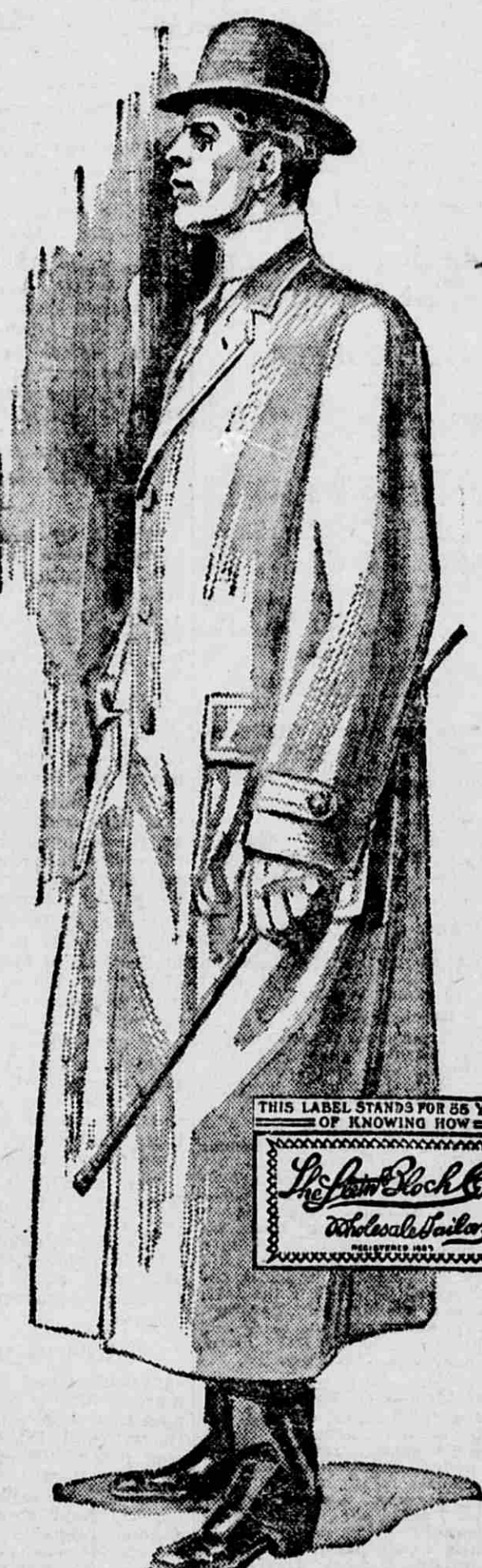

and William of Schoolcraft.

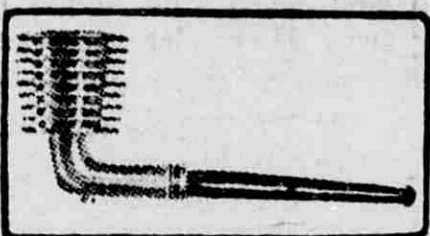

COMMONWEALTH PLANS TO IMPROVE

Will Build New Line Into City
for Transmission; Old Poles
to Be Taken Down if Per-
mit Is Granted.

A number of important changes in
the transmission lines are contemplated
by the Commonwealth Power Co.,
among them a reconstruction of the
wiring system leading into the city
from the north.

It is proposed to run the lines over
private property from the Williams
mill at the north corporation limits,

erable distance.

If the permit is granted, all the

VERDON CIGAR CO. OFFICERS QUIZZED

Attorneys For Creditors Ask

Two of Them About Assets;
Shrinkage Explained as Be-
ing Only Apparent.

At the meeting of the creditors of
the Verdon Cigar Co., adjudged bank-
rupt, held before Judge Henry O.
Briggs, referee in bankruptcy, Mon-
day afternoon, John A. Hoffman,
president of the company, and Law-

sented the creditors at the hearing,
while Trustee S. V. Earl was repre-
sented by Boudeman, Adams & Wes-
ton.

The hearing was adjourned until
Nov. 1.
